1.0 Introduction

Adaptation at Scale Prize Project invites, involves and encourages selected international, national, community-based and private organizations working in the areas of climate change adaptation (CCA) in Nepal to develop new and innovative ways to scale-up and scale-out community driven CCA initiatives and actions focusing on the vulnerable, marginalized and poor communities. It had offered financial rewards to competent organizations as *Protsahan* (Encouragement) Prize in Stage 1 that concluded in Dec 2016. It is believed that the Protsahan prize winners are already developing innovative plans to scale up/scale out their existing successful adaptation projects. Stage 2 is planned to implement and provide *Karyanwayan* (Implementation) Prize, which is commenced in March, 2017. It is designed to prepare, involve and select the most successful organizations registered for competition that will demonstrate successful up scaling and out scaling of their CCA initiatives through evidence creation in terms of outcomes and impacts.

The *Protsahan* Prize was awarded in December 2016 to community driven projects with positive results and authentic evidence of potential to scale-up and scale out by covering larger areas and benefitting added number of people. The winners had clear objectives and innovative implementation plans for expansion and outreach. The *Karyanwayan*Prize was launched in March, 2017 and will be awarded to organizations that exhibit positive outcomes for poor and vulnerable communities using new and innovative approaches, tools and practices.

If not addressed properly, climate change impacts individuals, households and communities, especially poor and marginalized groups. Adaptation at Scale Prize Project (A@SPP) aims to identify and reward organizations promoting new and innovative ways to scale up and scale out community driven climate change adaptation initiatives, through cash awards.

After the successful completion of Stage 1 (*Protsahan* Prize), the Stage 2 (*Karyanwayan* Prize) of A@SPP is planned to run from March, 2017 till December 2018. Stage 2 is managed by a consortium of three organizations working in the CCA and related areas comprising of IDS-Nepal, CGED-Nepal and SIAS henceforward to be called the Nepal team. This is a sub-contract arrangement with the main contractor-IMC Worldwide led consortium based in United Kingdom, financed by Department for International Development (DFID) of the UK Government.

As a part of the implementation process of the Stage 2 of the A@S Project, the Nepal team first analyzed and prepared list of 39 shortlisted organizations from Stage 1 (15 winners of the

protsahan prize and 24 registered applicants for Prothasan Prize in Stage 1). In order to give opportunities to underrepresented Mid- and Far- Western Development Regions of the country, the Nepal team invited additional participants to make the total list of participating organizations to 48 (see Annex 1). These are CCA relevant organizations selected through criteria based process ensuring that all the provinces and ecological zones of Nepal were represented. The selected organizations comprises of INGO, NGOs (Both national and district levels), CBOs and private sector entities from all parts of Nepal. Upon completion of the selection of the partners showing their interest to participate in the competition, the Nepal team conceptualized, designed and organized the Project Orientation and M&E Training Workshops for selected participants from different parts of Nepal at three different locations: Kathmandu, Hetauda and Nepalgunj) ensuring easy accessibility with the following objectives:

1.1 Objectives

- ✓ To introduce A@S Stage 2 project and process to the participating organizations, and
- ✓ To orient conceptual issues and practical implementation approaches methods and monitoring processes.

The workshop also aimed at contributing to capacity gap analysis and knowledge building of the participants especially in monitoring of the Scaling-up and Scaling-out adaptation activities.

1.2 Workshop Structure, Methods and Process

The A@S Stage 2 Project Orientation and Monitoring & Evaluation (M&E) Training Workshops were conducted in three different locations of Kathmandu (Kathmandu valley), Makawanpur (Hetauda) and Banke (Nepalgunj). This two-day workshop covered the entire gamut of conceptual, practical and cross secectoral aspects of climate change vulnerability, impacts and adaptation needs as well as approaches. The training materials prepared and delivered were based on the needs of the Stage 2 project wherein existing CCA work of the collaborating partners are to scale up and out. Altogether 6 experts led by the Team Leader delivered carefully prepared lectures and interactive discussions expecting to meet the needs of heterogeneous groups of participants. It was observed that the participants took keen interest in sharing their expectations, knowledge and experiences on the adaptation work they have been undertaking in the areas of climate change adaptation. Each delivery of the expert presentation, interactive discussions took place during all the three the workshops.

The expert teams comprising of Dr. Madhav B. Karki, Dr. Dinesh C. Devkota, Dr. Lokendra Poudyal, Mrs. Prabha Pokhrel, Mr. Prakash Koirala, Dr. Sarba Raj Khadka and Mr. Ngamindra Dahal prepared and delivered lectures covering topics from the evolution of project Idea to Impact (I2I); CCA focus of the I2I project in Nepal; objective of the project, climate change relevant components and sectors – both thematic and cross sectoral - coverage of the project as well as intention to generate policy relevant evidence. These expertsworked both as the facilitators and resource persons for the workshops. Special efforts were made to familiarize the participants with the innovative and upscaling related topics—such as CCA scaling up and scaling out, monitoring and evaluation, gender equality and social inclusion, climate change policy and too 'much too little' water management, and information and communication strategy in the context of adapting to climate change derived changes and challenges.

The workshops were initiated through a brief opening and introductory sessions attended by guests and PAC members. These opening sessions helped to set tones for the following sessions. In Kathmandu, PAC Chairperson Dr. Ram Prasad Lamsal, PAC members Ms. Naresh Sharma, Kanchan Lama and Dr. Madan Koirala and the former Vice Chairman of National Planning Commission of Nepal Dr. Dinesh Chandra Devkota and the team leader Dr. Madhav Karki had covered different aspects of the project and shed light on the relevance and importance of the project and orientation cum training workshop. They also highlightedamong other things, the national relevance of the project and the roles of different partners to inform and influence policies and programmes at different levels. In Makawanpur workshop, invited quests from Ministry of Forests and Soil Conservation and Institute of Forestry highlighted the significance of climate change management related programmes and projects for their own organizations and the need for multi-stakeholder approaches to address the causes and consequences as a result of climate change. In Banke, during the opening session, the former Vice Chairman of National Planning Commission of Nepal shared global and national scenarios of climate change and how they are impacting the lives and livelihoods of Nepalese people. They also highlighted the significance of climate change adaptation activities that are homegrown and encouraged the participants to work with their limited resources but unlimited knowledge for upscaling and replicating best practices to reduce the impacts of climate change in both short and long run.

Dr. Madhav Karki, Team Leader of A@SPP and Executive Director of CGED Nepal had a privilege to welcoming all the guests and participants of the workshop, introducing the objectives of the workshop and presenting the overview and the implementation process of the project. Mr.

Prakash Koirala, Communication and Media Expert and Executive Director of IDS Nepal had facilitated the opening sessions.

2.0 Expectations of the Participants

After the opening session, the participants were required to share their expectations. In the meantime, each of them (except in Kathmandu workshop) was also given short time for sharing their experiences, ongoing activities and future plans in relation to climate change adaptation. Each participant attending the workshop had individual expectations form the workshop. Some common one are listed below,

- ✓ To gain knowledge on climate change indicators/tools and vulnerability analysis tools
- ✓ To know local activities and influencers at rural municipality level to follow up on their implementation and sustainability
- ✓ To know evidence based impacts of climate change at local levels
- √ To learn on climate change issues in Nepal from different experiences.
- ✓ To know how climate change programme and funds can be channelized at local/
 provincial levels
- ✓ To learn about the major indicators and importance of M& E
- ✓ To get ample information (Basic to effect on human life) and ways to cope with and
 mitigate it
- ✓ To know the root causes of climate change and its solution (shortterm and long term)
- ✓ To learn about training and orientation of new and innovative ideas around the world and
 its replication in their projects
- ✓ To be acquainted with the concept of budget, plans and other supporting polices.
- ✓ To know the various platforms to transfer information regarding disaster and climate risks
- ✓ To know the trend of climate change in Nepal (quantitative database)
- ✓ To be acquainted with indigenous technologies to adapt climate change capacity development
- ✓ To gather knowledge on how to identify and document relevant knowledge
- ✓ To know the difference between climate change adaptation and resilience
- ✓ To know proper documentation techniques of their work
- ✓ To know about platform and way forward for networking with NGOs and Government.
- ✓ To be a part of adaptation network enabling the learning and sharing of experiences.

✓ To gain knowledge of sustainable environment, Gender Equality and Social Inclusion (GESI) and finance related issues

3.0 Delivery of Technical and Thematic Contents

Sharing of expectations and presentations on their activities was followed by thematic sessions relevant to the project. The thematic experts delivered on different thematic issues in each workshop.

Dr. Madhav Karki's (Team Leader & Climate Change Adaptation Expert) presentation was focused on general introduction of the project, consistent with the understanding of climate change adaptation, scaling up and scaling out among project partners, understanding adaptation at scale prize project and methodology for implementing stage 2 of the programme.

Dr. Lokendra Poudyal (Monitoring& Evaluation Expert) focused on M&E concepts and indicators in relation to Climate change A@S prize project. He also highlighted the outcome of the project, areas of intervention and monitoring indicators.

Mr. Ngamindra Dahal(Climate Change & Water Expert) focused on local level adaptation for 'Too Much or Too Little Water Management'. His concern waswhat community or organizations are doing towards drinking and irrigation water and the causes of 'too much and too little water', and the issues of its management in both the scenarios.

Ms. Prabha Pokhrel (Gender Equality & Social Inclusion Expert) focused on GESI policies and practices in the context of Climate Change Adaptation.

Mr. Prakash Koirala (Media Expert) focused on Communication strategy and role of media in climate change adaption scaling up and scaling out initiatives in Nepal. He concentrated on the role of knowledge management and media in sharing information about good practices.

Dr. Dinesh Chandra Devkota (Climate Change and Policy Expert) focused on challenges posed by global climate change and need for adaptation, scope for reforming and restructuring National and sub-national climate change policies through innovative local adaptation practices. He also touched upon the importance of adaptation at scale prize programme.

Dr. Sarba Raj Khadka (Project Manager) covered the overall organization and management aspects of A@SPP under Stage 2, including workshops, and discussed the important sections of the Stage 2 registration form.

4.0 Training Needs Assessment

Training need assessment helps to identify performance necessities of the program as well as the knowledge, skills and abilities needed by participants. Efficient training need assessment also facilitates mobilization of resources in the project area. Training needs assessment sessions followed the thematic sessions and preceded the feedback sessions. Training needs assessment sessions were facilitated by supplying a list of the possible need areas, with options to add any other particular needs.




Figure 1: Diagram demonstrating the training needs of the participants

A total of 52participants had submitted the needs list for the analysis. As presented as Figure 1, four indicators have been used for the needs assessment. Indicator 'High' denotes that

participants considered the topic to be utterly important in their project implementation. Likewise, 'Medium' denoted its usefulness in the project and 'Low' meant that the topic is not required in their project, whereas, 'Very low' signified their prior-possession of the topic's knowledge.

The highest need felt by the participants was on climate change adaptation followed byproject planning, monitoring and reporting, and then evidence based advocacy, lobbying and campaigning and training. Medium need was felt on governance and organization development. Participants kept accounts keeping and finance management in very low priority.

5.0 Feedback on the Workshop

Around the end of the workshop, a feedback and evaluation session was put in place for encouraging the participants to rate different dimensions of the workshop – content, design, duration, results, logistics, etc.

5.1 Workshop content, design and results

As per evaluation form, almost all participants agreed and/or strongly agreed that the content presented in the workshop fulfilled the stated objectives and achieved the learning outcomes. More than 90% respondents thought that the content was up to the mark, objectives were clear, instructors were well prepared and they could use learned knowledge at workplace. 19% participant believed venue of the workshop didn't matter and 13% felt that difficulty level in actuality does not matter in the workshop.




Figure 2: Diagram demonstrating the evaluation criteria and participants' responses

5.2 Areas to improve

Overall the participants found the workshops to be very appropriate, interesting and knowledgeable. There were few feedbacks from participants in order to further improve it. For example, suggestions are to increase time for interactive discussions. Out of 37 suggestions, twenty one emphasized in making the workshop more relevant. Similarly, 18 suggestions were for enhanced content coverage, whereas, few were just the opposite. 17 comments regarding updating the content was also obtained as well as to make the workshop easier along with increased time. Few proposition were to slow the pace of presentations and on workshop organization.




Figure 3: Diagram showing comments regarding the ways to improve the workshop

In addition to written suggestions, a select numbers of participants were given the floor to express their overall observation about the workshop. And almost all observed that the workshops were very much relevant and useful to conceptually guide their planned undertakings in climate change adaptation.

6.0 Issues and Challenges for A@S Prize

Some issues and challenges as, mentioned below came across in the planning and operation of the project,

- Implementation Fund: Generally, there is no issue for INGOs and National NGOs to implement their plan as they have adequate fund but Local NGOs and Community User groups (CUG) have to face such challenges. Due to which, a number of participants could give up the competition.
- Documentation: Local NGOs and Community user groups could not properly deliver their ideas and its implementation due to the lack of knowledge of documentation
- INGOs and national level NGOs have higher knowledgecompared to CUGs, therefore there might be biasness in selection process.

- 4. As various organizations are located in different geographical area, it could be difficult to monitor all of them in the limited time period.
- 5. Appropriate use of the prize money for innovative climate change adaptation cannot be guaranteed

7.0 Outcomes

The workshop contributed in familiarization of the project and capacity building of the participants on monitoring of scaling-up and scaling-out activities. It also helped participants to develop M&E indicators of CCA plans with the assistance of project's expert.

8.0 Recommendations

The following points have been recommended for consideration in future project interventions:

- Sharing of all case studies through visual presentations and increase group work as well as cross learning interactions
- 2. The workshop could be of 3-5 days in length
- 3. Evaluation criteria for A@SPP should be clearer and more specific
- 4. More content about adaptation definition and adaptation measures, and other such topics
- 5. Presentation can be clearer and concise as well as delivery in Nepali language is desirable.

9.0 Next Steps and Way Forward

The following points briefly presents the next steps and way forward of this project,

 Learning and sharing papers (policy briefs, newsletters on innovation, up scaling, out scaling and innovative topics of interest with all stakeholders

- 2. Collect all registration forms on or before 07 July 2017
- Develop training modules, training curricula, materials and partner monitoring criteria and tools as well as organize training and capacity development sessions before 15 September 2017
- 4. Swift field implementation after September 2017
- 5. Six monthly monitoring report collection from partners
- 6. Consistent six-month monitoring

10.0 Conclusion

The critical importance of developing and expanding adaptation to climate change in Nepal can be overemphasized. Currently, Nepal is facing a serious deficit of the adaptation projects, programmes and practices. The A@SPP aims to fill in this deficit by encouraging, incentivizing and technically supporting innovative indigenous, autonomous and planned adaptation initiatives. The 45 partners who have shown interest to join this mission have undergone basin orientation and learning training. The Nepal team experts have found tremendous amount of innovative ideas, enthusiasm and interest among them to scale up and scale out their CCA practices. This orientation cum training workshop is the foundation for subsequent capacity building of these partners to prepare all of them to be competent to do successful work and be competent not only to win the prize but more importantly become a important contributing member of the innovative adaptation community of practice in Nepal.








Figure 5: Photos from Makawanpur (Hetauda) Workshop
